# Architectural & Design Services Village of Penn Yan DRI Building Improvement Fund

January 27, 2020

# **Overview**

The revitalization of downtown Penn Yan will propel long-term regional prosperity and provide year-round opportunities for all residents and visitors to enjoy the area's natural assets, local foods and beverages, arts, and creative economy in an attractive and accessible destination. In alignment with the Penn Yan DRI vision statement, the Village is seeking to improve the utilization of vacant and underutilized property, attract and expand businesses, create mixed-income residential units, and attract resident's downtown.

The Finger Lakes Horizon Economic Development Corporation (FLHEDC) has been awarded funding through the New York State Downtown Revitalization Initiative (DRI) to finance a Building Improvement Fund. A \$600,000 Building Improvement Fund has been established to provide grant funding for applicants to implement interior and exterior building improvements in the Village of Penn Yan DRI area. Goals of the Penn Yan DRI Building Improvement Fund are to preserve and renovate historic downtown buildings, stimulate entrepreneurism, and promote mixed-income residential uses including upper-floor units. The fund is available to any commercial and/or mixed-use building owner within the Village of Penn Yan DRI boundary.

The FLHEDC will also be administering two additional projects that were directly awarded DRI Funds. \$300,000 was awarded to 131-147 Water Street and 120 Wagener Street to transform a currently vacant lot into 18 townhome condominiums to create additional housing for both seniors and young people. \$150,000 was awarded to 126 Main Street to convert vacant second floor space into three rental apartments. Renovations will include demolition, installation of drywall, electrical, plumbing, HVAC and window replacements.

The Building Improvement Fund will mimic many of the goals, process and requirements of the NYS Main Street Program that includes providing funds for administration of the program by the FLHEDC. Funds are also available for limited soft costs including architectural and environmental services for the Building Improvement Fund, 131-147 Water Street and 126 Main Street projects.

# Scope of Services

- The FLHEDC is seeking an Architectural and Design Firm licensed in New York State that has or will
  obtain environmental scoping capabilities. Services to be provided will be retained to assist the
  FLHEDC in overall program management, design and compliance as follows: conduct an inspection of
  subject properties (estimated 5 to 10 properties) to gather and assemble all necessary information to
  properly document the existing conditions and requirements of each project, including but not limited
  to environmental, structural, mechanical, and electrical data.
- Assist the FLHEDC with evaluation and scoring of Building Improvement Fund applications.
- Assist with SHPO impact determination and guide projects, as necessary, to satisfy SHPO conditions.

- Prepare a preliminary schematic design for each construction/ renovation project as authorized by the FLHEDC.
- Assist projects to meet all procedures and requirements mandated in the HTFC environmental determination letter.
- Provide a cost estimate for each project, as requested by the FLHEDC.
- Oversight and coordination of building owners bidding process.
- Assist with progress inspection, and/ or completion inspection as authorized by the FLHEDC.

**<u>126 Main St.</u>**: The total budget for the scope of services cannot exceed \$10,000
