

NEW YORK STATE LEGISLATURE ACT  
ESTABLISHING THE YATES COUNTY  
INDUSTRIAL DEVELOPMENT AGENCY

Following is a certified excerpt from New York State General Municipal Law § 893-b, "Yates County Industrial Development Agency."

For the benefit of the county of Yates and the inhabitants thereof, an industrial development agency, to be known as the YATES COUNTY INDUSTRIAL DEVELOPMENT AGENCY, is hereby established for the accomplishment of any or all of the purposes specified in title one of article eighteen-A of this chapter. It shall constitute a body corporate and politic, and be perpetual in duration. It shall have the powers and duties now or hereafter conferred by title one of article eighteen-A of this chapter upon industrial development agencies and provided that the exercise of the powers by such agency with respect to the acquisition of real property whether by purchase, condemnation or otherwise, shall be limited to the corporate limits of the county of Yates, and such agency shall take into consideration the local zoning and planning regulations as well as the regional and local comprehensive land use plans. It shall be organized in a manner prescribed by and be subject to the provisions of title one of article eighteen-A of this chapter. Its members shall be appointed by the governing body of the county of Yates. The agency, shall in all respects be governed by the provisions of title one of article eighteen-A of this chapter.

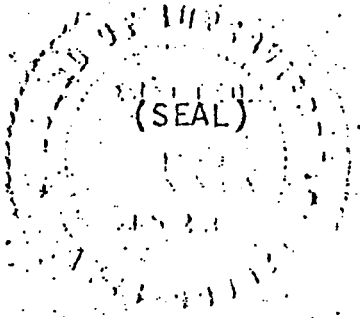


