## FINANCE COMMITTEE

Also presented today was Check #361 for \$10,270.76 from the Finger Lakes Horizon EDC and Check #101 for \$25,000 from the Yates County Capital Resource Corp. *A motion was made by Dr. T. Cutler and seconded by Dr. K. Pinkey to pay all bills submitted totaling \$43,762.59, from the checking account and \$1,729.08 from the Revolving Loan Fund. with the check numbers presented. Motion passed.* 

## STATUS REPORT

D. Jensen reported she is working on updating the Capital Projects for 2024-2028 and the 2024 budgets.D. Jensen requested suggestions and comments on the Capital Projects and the 2024 budgets.

M. Lipari reported he had a meeting with Regional Representatives from the Small Business Administration. The Regional Reps met with the Yates Chamber of Commerce after their meeting with Mike. The three organizations will work to together to host a small business resource event in November. More information will be forthcoming as the details of this event move forward.

M. Lipari reported that the Community Dinner sold out in 4 minutes. The Committee is already discussing plans and changes for next year. The Chefs are finalizing the menu and are working to tie the menu into Yates County's Bicentennial theme. There was discussion on the Community Dinner.

S. Griffin reported the Regional Council had their meeting at Seasons Conference and Banquet Center in Penn Yan on August 10th. The feedback from this meeting has been positive. A number of meeting attendees brought their spouses and stayed for the weekend. Laurentide and True Roots hosted roughly 60 attendees for an invitation only lunch and they did a phenomenal job. S. Griffin reported M. Lipari and the Yates Chamber of Commerce worked hard to put promotional materials together to hand out at the meeting. This was the first meeting that materials were distributed.

S. Griffin reported based on the above he is on a new steering committee.

S. Griffin reported that he will be reaching out to the United Way of Northern Yates County to learn about their organization.

S. Griffin reported on attending the Stork Award Luncheon and participating in Community Day at Keuka College.

## **ACTION ITEMS**

D. Jensen reported that the HVAC bids were sent to 5 local contractors and to TRANE. Joe and I met with two of the contractors. The bid was for a 15-ton replacement HVAC unit. Bids were opened at this time. Bids received were from M2 Heating, Cooling and Electric for \$48,871.87 and JR's Heating & Cooling for \$37,389.52. *A motion was made by Dr. T. Cutler and seconded by Dr. K. Pinkey to award the HVAC bid to the lowest bidder of JR's Heating & Cooling as presented. Motion passed.* 

S. Griffin reported Hawk Custom Construction, LLC and Verminx Pest Control, LLC would like to lease Suite 133, 134 and 135 which is 2,840 square feet for one year at \$1,630 per month and \$150 per month utility charge.

S. Griffin reported Aqua Source, Inc. would like to lease Suite 207 which is 375 square feet for \$465 a month. This is a six-month lease.

A motion was made by S. Garcia and seconded by Dr. T. Cutler to approve the leases with Hawk Custom Construction, LLC, Verminx Pest Control, LLC and Aqua Source, Inc. as presented. Motion passed.

Chair R. Hallings reported the next meeting is scheduled for September 20, 2023.

A motion was made by Dr. K. Pinkey and seconded by S. Garcia to adjourn the meeting at 9:33 A.M.
